Piano and Keyboard Program

Dear Parent:

Music on the Move is returning to Nativity of Our Lord for the coming school year, 2017 - 2018. The nation's number one music program is offering a great way to learn to play the piano or keyboard. Advanced or beginning instruction is available.

- *Students learn during half-hour group/private lessons or 15 minute private lessons.*
 - *Lessons will be given once a week during the school day except for holidays.*
 - *Students will give a recital in the month of May.*

Instruments Offered

Piano, Keyboard

*Grades 1-5**

(*1st Grade lessons will be held only after school.)

(**Junior High students can take lessons by special arrangement.)



Fee Schedule

An annual fee of \$46.00 covers the cost of all lesson books, supplemental books and handouts that your child will need. This fee must accompany the registration form on the other side. Lessons are divided into two semesters, 15 weeks each.

Tuition payment per semester for half-hour group lessons or 15 minute private lessons is \$165.00 (\$11.00 per lesson) plus the \$46 registration fee, payable before the first lesson. Half hour private lessons are available for \$285.00 (15 weeks at \$19.00 each) plus the registration fee. You may use Discover, Visa or MasterCard for lesson payments.

Instruments

Students do need an instrument to practice on. Please call the MOMM office for information on purchasing a keyboard. If you own a piano, it is important to tune it at least once a year.

Registration

To have your child participate in the Music on the Move program, complete the registration form and return it with the \$46.00 registration fee to the address below. Please pay for registration by check or money order made payable to Music on the Move Minnesota. **DO NOT SEND CASH.**

Education Tax Credit
